#### 4) Overview of Tuition Payment Assistance Options

#### A. Sibling/Multiple Child Discount

• First child is full tuition. 5% decrease in tuition for 2nd child enrolled at Arlington Christian School. 10% decrease in tuition for 3rd (and subsequent) child enrolled at Arlington Christian School.

#### **B.** Georgia Financial Aid and Scholarship Information

#### C. Arlington Financial Aid & Scholarships

• Athletic Scholarships will be contingent upon our current enrollment, certain restrictions will apply given tight financial restraints.

#### D. Arlington Enrollment & Re-Enrollment Fees

- Upon acceptance as a new student, there is a \$300 new student enrollment fee to reserve your space.
- All current ACS Scholars qualify to have the \$300 re-enrollment fee waived through May 15, 2022.

### **E.** Arlington Application Fees

• There is a non-refundable application fee of \$150. This includes the fee for pre-entry testing for all grades. (Gessell School Readiness Test administered to K through First grade applicants; Standardized Achievement Testing to applicants for grades 2-12).

#### F. IEP and Special Needs

• Arlington Christian School accepts scholars who qualify for the SB-10 scholarship. If you desire your child's IEP to be reviewed to determine if ACS would be a good fit, please contact our office.

## **G. Tuition Insurance Plan**

• The Tuition Insurance Plan is required of all families choosing to finance their tuition monthly through the Arlington business office.
